

Understanding Eligible Services Reporting

All Ryan White HIV/AIDS Program (RWHAP) agencies will be required to complete Eligible Services reporting beginning with the 2021 RWHAP Services Report (RSR). Previously, RWHAP providers used Eligible Scope reporting to determine which clients would be included in the RSR. Under Eligible Scope, providers only reported data on clients who were RWHAP-eligible and received a service for which the provider received RWHAP funding. Under the new Eligible Services Reporting requirement, providers will be required to **also include services funded through RWHAP-related funding,** which includes program income and pharmaceutical rebates.

Eligible Services

Eligible Scope

Report data on clients who are RWHAP-eligible AND received at least one service for which the provider received RWHAP funding

(+ NEW)

OR received at least one service which the provider used RWHAP-related funding (program income or pharmaceutical rebates) to provide

Why the change?

HRSA HAB periodically updates the RSR to best measure the full investment of and demonstrate the impact of the RWHAP at state and local levels. As a payor of last resort, RWHAP funds will not be used to pay for services that have been paid or can be reasonably expected to be paid by another payment source.

The Health Resources and Services Administration HIV/AIDS Bureau (HRSA HAB) moved to Eligible Scope reporting for the RSR in 2015 to **capture all eligible clients who received HIV-related care and treatment supported by other payers** (e.g., Medicaid, Medicare and private health insurance). Recently, however, more recipients have moved toward funding services with RWHAP-related funding (program income and pharmaceutical rebates). To fully measure RWHAP investments and impact, HAB has now introduced Eligible Services reporting.

The addition of Eligible Services reporting does not impact who is eligible for the RWHAP. It only means that recipients and subrecipients must now also include data on clients receiving services provided through RWHAP-related funding (program income and pharmaceutical rebates) in their Recipient and Provider Reports.

Who should be reported on the RSR?

To be included in the RSR, the client must:

- Meet the recipient's eligibility requirements for RWHAP participation (generally based on HIV status, income level, residence); and
- Have received at least one of the core medical or support services for which the provider receives RWHAP or RWHAP-related funding. For a full list of service categories, see PCN 16-02.

What counts as a RWHAP-related funded service?


RWHAP-related funded services are services provided in service categories that are partially or fully paid for with revenue generated by the RWHAP; this includes program income and pharmaceutical rebates. See PCNs 15-03 and 15-04 for more information on program income and pharmaceutical rebates.

Service categories that are ONLY funded by non-RWHAP sources, such as other federal funding, other state or local funds, or other sources are not reported.

Example: Clinic Receives RWHAP and Related Funding for OAHS and MCM

South City HIV Clinic receives RWHAP Part C funding for outpatient/ambulatory health services (OAHS), RWHAP Part B pharmaceutical rebate dollars for medical case management (MCM) services, and Substance Abuse and Mental Health Services Administration (SAMHSA) funding for mental health services. The figures below show what services are RWHAP or RWHAP-related, and which clients and services should be reported.

Service	Funding Type	Include in RSR?
OAHS	RWHAP funded	Yes
MCM	RWHAP-related (pharmaceutical rebates)	Yes
Mental Health	Other federal funding (SAMHSA)	No
